FACTS	WHAT DOES SMARTPAY LEASING, LLC ("SmartPay") DO WITH YOUR PERSONAL INFORMATION?

What we do	
How does SmartPay protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  We also restrict access to your personal information to those employees who need to know this information to perform their job duties.
How does SmartPay collect my personal information?	We collect your personal information, for example, when you:  Apply for a lease or give us your contact information,  Open an account or give us your income information,  Provide employment information.  We also collect your personal information from others, such as consumer reporting agencies, affiliates or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only:  sharing for affiliates' everyday business purposes - information about your creditworthiness,  Affiliates from using your information to market to you, Sharing for nonaffiliates to market to you.  State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
	<ul> <li>Our affiliates include companies doing business as Allied Cash Advance, Check 'n Go, Axcess Credit, SmartPay Leasing, LLC, TEMPOE, LLC, and their related holding and back-offices service companies.</li> </ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  Nonaffiliates we share with can include debit card companies, banks, servicers, data processors, data research firms and other financial institutions.
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.  Our joint marketing partners include retail companies.
